## **Application Procedures**

## **ADMISSION REQUIREMENTS**

- 1. 17 years of age (during first semester of study)
- 2. High School certificate or equivalent
- 3. School or work testimonials
- 4. Proficiency in English (500 TOEFL / 5.0 IELTS / JETSET level 5 or higher)

## **MATURE AGE ENTRY**

Relevant work experience may be considered instead of formal qualifications for applicants above 21 years old.

#### TRANSFER STUDENTS

Transfer students from other accredited hotel and tourism programs will be assessed individually for certain course exemptions. Note - Whilst academic qualifications are important criteria, the Selection Board considers personality, motivation and aptitude as overriding factors in the selection process.

## **VISA & STUDENT PERMIT**

A small number of nationalities are required to apply for an entry visa to Malta. Please check with the local ITIS representative or Maltese Embassy. You should apply for the visa at the Maltese Embassy when you have obtained a letter of Acceptance from ITIS or you can send us your full details by fill the Entry to Malta Application form and send it to us with your application. In some cases, students from certain countries must pay their full year's fees before the visa can be processed.

#### APPLICATION CHECKLIST

The following application documents are required:

- · Completed application form
- Registration & application deposit (non-refundable of Euro 600 made payable to "ITIS Malta"
- · Copies of School certificates with subject grades
- School or work testimonials (if applicable)
- · Certificate of English proficiency, TOEFL or IELTS or JETSET or equivalent
- Four passport-size photographs (3.5cm x 4.5cm, colour)
- A medical certificate duly endorsed by your doctor
- · Copy of passport
- Copy of Travel Insurance (Students must be properly insured to cover health and accident insurance)

Note The registration deposit must accompany all applications. ITIS Malta will not process any incomplete application for admission.

## TRANSFER STUDENTS

- · All documents listed above for new applicants
- Official transcripts or records for each term, semester or year of previous course of study.

## **ADMISSION ADVICE**

On receipt of the application the ITIS Malta Admission Committee will endeavour to respond promptly, normally within 3-4 weeks at the latest. If selected, you will receive an official letter of Acceptance with your deposit held as guarantee for the place reserved for you. If a place is not immediately available for a particular course semester you applied for, you will be placed in a priority wait-list whilst at the same time offered a place in the next immediate term. All successful students will receive an information package from the school which would help you in your preparations for studies in Malta. ITIS Malta is not obliged to offer any reason for not accepting a student, unless the student does not meet the entry requirements.

## **CLOSING DATE FOR APPLICATIONS**

ITIS Malta has one course intakes per semester each year, first semester start on the last Monday of October. At ITIS Malta we follow a rolling admissions policy accepting students on a "first come-first served" basis when they meet all our entry requirements. Closing date for applications is two months before each intake, however we strongly advise an early application (preferably four months before each intake).

## **COURSE FEES**

Fees for all courses are per semester, payable at the latest 4 weeks before the commencement of your semester. Fees are to be paid in full.

#### **DEPOSIT**

Registration/Application deposit for Courses held in Malta

In addition to course fees, all students must pay a registration/application deposit of Euro 600 with the application. If accepted, this deposit guarantees your place in the school. The deposit is used for any Government taxes, Administrative fees and University registration fee

## **SEMESTER DEPOSIT**

At the end of each study semester, excluding Semester 2, a deposit of Euro 600 is payable to guarantee your place in the next semester course. The deposit fee may be used for any "top-up" to cover shortfalls in any insurance charges or other incidentals.

#### **UNPAID BILLS**

No student will be admitted into the class or residence until all school fees and deposits have been settled. Students whose bills are overdue by 30 days will face instant dismissal. They are still legally obliged to pay fees for the entire course semester. Should any students be in arrears of fees payable to the school by the end of their course, ITIS Malta reserves the right to withhold any graduating certificates, transcripts and testimonials. All payments may be made by a bank draft in US dollars only payable to "ITIS Malta" and sent to the school by registered mail or by a bank transfer directly to the Institute's account.

#### REFUND POLICY

Students whose applications are not accepted for other reasons then not satisfying the entry requirements or whose visa application is rejected will receive a full refund of the registration deposit or course fees paid less bank changes. If during semester, a student withdraws from the school for any reason there is no refund. There is no refund of any fees in the case of students who are dismissed (academic / disciplinary reasons) from the school.

#### SEMESTER DEPOSIT

Should there be any cancellation, the school must be notified in writing by registered mail at least 30 days before commencement of course. In such cases, 50% of the deposit will be refunded. There will be no refund for late withdrawals.
